

**TERMS AND CONDITIONS**  
**FOOTBALL FIESTA 2018**

**1.0 Campaign Period:**

1. This Contest is organized by Al-Ikhsan Sports Sdn Bhd (Al-Ikhsan Sports) and shall commence from **6 April** until **9 June 2018** (“Contest Period”).

**2.0 Eligibility:**

- 2.1 The Contest is open to all customers who purchase football products worth RM500 and above in single receipt at any Al-Ikhsan Sports outlet OR Football Republic store OR Football Fiesta Road Tour locations (“Eligible Participant”).
- 2.2 Customers who purchase football products worth minimum RM500 at any Al-Ikhsan outlet OR Football Republic OR Football Fiesta Road Tour locations using cash or credit and debit card are entitled to one (1) entries.
- 2.3 Customers who purchase football products worth minimum RM300 at any Al-Ikhsan outlet OR Football Republic store OR Football Fiesta Road Tour locations using AEON Credit card are entitled to two (2) entries

**3.0 Qualifying Conditions:**

- 3.1 Eligible Participants will have to purchase any football products worth RM500 and above in single receipt at any Al-Ikhsan Sports outlet or Football Fiesta Road Tour locations.
- 3.2 Eligible Participants will be required to complete the Contest form provided by the cashier to enter the Contest.
- 3.3 Eligible Participants will be required to answer 1 simple question (from Al-Ikhsan Sports) and create a slogan (5 words)

  - a) In store submission – Eligible Participant will be required to place the contest form in the contest box provided in Al-Ikhsan Sports outlet OR;
